After graduation, he worked at UC Santa Cruz as a Hydrogeology Research Technician, where he conducted and presented research at sites being used or tested for managed recharge.

# Coalition's Annual Monitoring Report Submitted to the Regional Board on May 1, 2022

The 2021 Annual Monitoring Report (AMR), submitted May 1 to the Central Valley Regional Water Quality Control Board, put a wrap on the 2021 surface water monitoring year (a "non-assessment year" which ran from October 1, 2020, to September 30, 2021). The AMR provides a detailed description of the Coalition's monitoring results during the monitoring year as part of ongoing efforts to characterize water quality impacts from irrigated agriculture in the Sacramento River Basin. Results continue to indicate that, with few exceptions, there are no major water quality problems as a result of discharges from agricultural lands in the Basin.

The majority of exceedances consisted of specific conductivity, dissolved oxygen, pH, and *E. coli*; all of which can be greatly affected by natural processes and sources not controllable by agricultural management practices. Non-pyrethroid pesticides were infrequently detected during the 2021 monitoring year (~7.0% of all pesticide results) and when detected, rarely exceeded applicable objectives. This is aligned with historical results in which over 98.1% of all pesticide analyses performed to date for the Coalition have been below detection. **However, pyrethroid pesticides should continue to be applied with extreme care and caution as they are still frequently being detected and at times, triggering exceedances.** 

# Ensuring Safe Drinking Water Though CV-SALTS

In 2006, the Central Valley Water Board initiated the Central Valley Salinity Alternatives for Long-Term Sustainability (CV-SALTS) as a cooperative effort among regulators, permittees (including agricultural water quality coalitions such as the Sacramento Valley Water Quality Coalition), environmental interests, and other parties interested in Central Valley water quality.

Through a **collaborative approach**, CV-SALTS works to establish a shared understanding of water quality challenges based on scientific studies and develop flexible, practical solutions that can be implemented collectively and cost-effectively to ensure safe drinking water is available to all communities.

While the State Water Board and the Central Valley Water Board are the state agencies overseeing the effort, the Central Valley Salinity Coalition, a group of urban, agricultural (dairy, wineries, and irrigated lands), wastewater, and other dischargers, guides research and planning and makes recommendations to the two state agencies. As a member of the Central Valley Salinity Coalition, NCWA and the California Rice Commission, represent Sacramento Valley agricultural interest in the Salinity Coalition.

There are two primary **program areas** CV-SALTS is focused on: long-term **salinity management** and **nitrate management**, which focuses on providing safe drinking water and improving nitrate management in high-priority areas including the Yolo Basin in 2022.

The CV-SALTS **planning process** utilizes elements of the Central Valley Water Board Basin Planning process to complete technical studies and make policy recommendations to the Central Valley Water Board and State Water Board. The agencies then consider the studies and recommendations for adoption into the two Basin Plans that govern water quality in the Central Valley, the Sacramento and San Joaquin Rivers Basin Plan and the Tulare Lake Basin Plan. ## On-Farm Drinking Water Well Requirement

Annual monitoring of on-farm drinking water wells for Nitrate + Nitrite as Nitrogen on **ENROLLED** parcels is required of all Coalition members by December 31, 2022. A drinking water well is defined as a well used for drinking or cooking.
